### **Kito Announced its Organization & Personnel Changes**

Tokyo, March 29, 2017 - Industrial hoist and crane maker Kito Corporation (head office: Nakakomagun, Yamanashi Prefecture; President: Yoshio Kito) announced organization and personnel changes in its board members in April 1, 2017 as follows, which were resolved and approved at the board of directors' meeting held today.

#### **1. Organization Changes as of April 1, 2017**

- 1)The CFO (Chief Financial Officer) shall be appointed to manage the Financial Management Division which will be newly established and the Business Strategy Division. The Financial Management Division shall be newly established not only to promote financial management, but also to manage the Corporate Communication Department in order for IR (Investor Relations) and SR (Shareholder Relations) to work more closely together. The Business Strategy Division which shall be also managed by the CFO, shall plan and execute the company's business strategic operations including PMI (Post Merger Integration).
- 2)The new department (Product Development Department III) shall be established in the Development & Technology Division which is under the management of the CPO (Chief Product Officer), in which crane components will be developed, in order to promote the strategies and development of our crane business.
- 3)The Business Division - Asia shall promote the realization of more proactive and efficient sales activities, and clarify the ownership of duties and shares in each region (block) by reviewing the range of their management responsibilities.
